Notice no. 03/2019 - Selection process for continuous flow of the PhD in Health Care Sciences - CLASS 2020

1. Opening

- 1.1 The Fluminense Federal University makes public, for the knowledge of interested parties, that the enrollment for the Selection Process for the Doctoral Course in Health Care Sciences, continuous flow, will be open from January 15, 2020 to July 31, 2020 for entry into the first academic period following approval.
- 1.2 The Doctoral Program in Health Care Sciences focuses on the Complexity of Nursing and Health Care and two lines of research, namely:
- 1.2.1 Care in the socio-cultural context.
- 1.2.2 Clinical care.

2 – Vacancies

- 2.1 21 (twenty-one) places will be offered for the doctoral course, corresponding to those offered by the supervising professors. Of these vacancies, 13 (thirteen) will be destined to Brazilian candidates, 04 (four) will be destined to foreign candidates and 04 (four) to affirmative actions (Annex I). If the vacancies for foreign candidates and candidates who meet affirmative actions are not filled, they will be transferred to other candidates who have been approved in the selection process, according to the classification criteria. According to CEP-UFF Resolution nº 18/2002, the foreign candidate is required to present the master's degree and the academic record of the master's course, both with authentication from the Brazilian Consulate in the country where they were sent and accompanied by certified translation.
- 2.2 The vacancies for the doctorate course will be distributed as follows: 60% of the total, destined to nurse candidates and 40% of the total destined to other candidates from similar areas. If the vacancies destined for candidates from similar areas are not filled, they will be transferred to nurse candidates approved in the Selection Process, according to the classification criteria.
- 2.3 Filling vacancies will meet the following criteria:
 - 2.3.1 vacancy (s) offered by the advisor, according to the table in item 2.5;
 - 2.3.2 candidate with the highest score for the position of the advisor.
- 2.4 The Selection Committee of the Post Graduate Program in Health Care Sciences reserves the right not to fill the total vacancies offered, if the candidates do not present the necessary requirements, according to the established criteria.

3 - Specific Qualifications of Candidates

- 3.1 It is a Selection Process, aimed at registered candidates, respecting the selection steps explained in this Notice.
- 3.2 The candidate must have completed the Master's degree in an official Higher Education Institution or recognized by the National Council of Education.
- 3.3 Titles obtained abroad must comply with Resolution 18/2002 of the Teaching and Research Council of Universidade Federal Fluminense CEP / UFF.
- 3.4 Nurses and other professionals with projects related to Health Care Sciences can register.
- 3.5 Present the documentation detailed in this Notice of Selection of candidates for the Course.
- 3.6 To be able to comply with the specific requirements of the Program, explained in this Notice and in the Program's Regulations.
- 3.7 Conduct a selection exam and meet the classification criteria explained in this Notice of Selection of Candidates for the Course.

4 - Subscription

- 4.1 Registration will be made at the Postgraduate Secretariat in Health Care Sciences of the Aurora de Afonso Costa Nursing School, **January 15, 2020 to July 31, 2020**, from **10 am to 4 pm**, upon presentation of documentation and proof of payment of the registration fee.

- 4.3 The candidate must present the following documentation upon registration:
 - a) Completed and signed registration form (Annex II);
 - b) A legible copy of the identity card and CPF; or for foreign candidate, passport;

- c) Two recent 3x4 photographs;
- d) Proof of payment of the registration fee in the amount of R \$ 350.00 (three hundred and fifty reais) to be deposited by the Union Collection Guide (GRU); https://consulta.tesouro.fazenda.gov.br/gru novosite/gru simples.asp, according to the procedure described in **Annex III**:
- e) A certified copy of the diploma or original statement of completion of the Master's Degree, recognized by a competent body of the Ministry of Education in the current year 2020; this declaration must state that the diploma is pending and that the candidate has no pending issues in the Program;
- f) Copy of the transcript of the Master's course. Titles obtained abroad must comply with CEP / UFF Resolution 18/2002;
- g) Curriculum Vitae according to CNPq's Lattes Platform, available at http://lattes.cnpq.br/index.htm, in three printed copies, which must be signed and dated; copies of the supporting documents of the curriculum vitae must be presented in a single copy numbered according to the items registered in the curriculum and bound; only items confirmed in the attached documentation will be considered;
- h) The candidate must present proof of publication or approval for publication (press) in one of the following options: **1st** two articles in *Qualis* B2 journal; **2nd** an article in *Qualis* B1 periodical and a book chapter with editorial committee and ISBN; **3rd** an article by *Qualis* A. The Qualis of the journal must meet the candidate's area of knowledge http://capes.gov.br/avaliacao/qualis in the last five years, counting from the registration date; for the foreign candidate, the impact factor of each publication will be required, considering the factor equal to 0.23 or higher;
- i) Proof of participation in a research group or letter of recommendation from a researcher;
- j) Declaration of availability and dedication of the candidate to the activities of the Program, described in the proper form (Annex IV);
- I) Letter of acceptance of the candidate signed by an advisor accredited by the Health Care Sciences Program, Doctorate course, following the model of the Program (Annex V). Letters from more than one advisor will not be accepted;
- m) Proof of foreign language proficiency (English or French), on letterhead and signed by an official Public Institution or Foreign Language Institution that grants certification, with a validity period of 2 years, counting from the registration date.
- n) Research project in 03 (three) copies, with indication on the cover page of the option for one of the Research Lines and name of the possible advisor, containing a maximum of **20 pages**, including cover page, schedule and references, presented in *Times New Roman*, size 12, line spacing 1.5 (model in the Notice **Annex VI**). Copies of the project must be signed and dated by the applicant;
- o) All material must be organized in a 40 mm yellow folder, with the candidate's identification tag;
- 4.4 Candidates residing in other states of the Federation will be able to enroll in the non-presencial modality, provided they present all the documentation required in item 4 of this notice.
 - 4.4.1 The sending of all required documentation through the Post and Telegraph Company, by registered letter or Sedex, must observe the last day of registration as the maximum postage.
- 4.6 Unqualified candidates will have a period of 30 (thirty) days, after the final result for removing the material delivered, from then on the material will be perforated and discarded;
- 4.7 Under no circumstances will there be a refund of the registration fee;
- 4.8 The selection process Committee will approve the registrations after checking the submitted documentation, within 10 working days.

5. Selection Stages

- 5.1 The filling of vacancies will take place through a process that will cover the following stages:
 - a) Evaluation of the Curriculum Vitae;
 - b) Evaluation and discussion of the Research Project and Curriculum.

6. Selection Schedule

- 6.1 For admission to the Course, candidates whose applications have been approved must submit to the selection exam, to be carried out in two stages:
 - 1st Stage Evaluation of the Curriculum Vitae by the Examining Board.
 - 2nd Stage Candidate's submission on the Research Project and *Curriculum Vitae* by the Examining Board, scheduled for up to 30 days after the registration is approved.
- 6.2 After the completion of the selection steps, the candidates will be classified according to the number of vacancies for each advisor professor, considering the final score and the number of vacancies established in this Notice.
- 6.3 The minimum score for qualification in the selection process is 6.0 (six).
- 6.4 The candidate can be qualified and not classified, according to the availability of the vacancy (s) of the supervising professor.

7. Registration

- 7.1 To be enrolled in the Doctoral Course, the candidate must have been approved and classified in the Selection Process
- 7.2 The enrollment of the student in the Program must be carried out within 60 days after the approval of the final result. Candidates who do not attend this period will be disqualified from the Selection Process.
- 7.3 Subscription in courses is mandatory in the first academic period following the enrollment, with the prohibition of any leave absence or total cancellation of courses, in which the student enrolled, in the period immediately after approval.
- 7.4 Candidates who fail to register within the deadline will be considered as dropping out of the Selection Process.

8. General Considerations

- 8.1 The results of the approval and the stages of this Selection Process will be signed and officially published on letterhead, to be posted on the Notice Board of the Health Care Sciences Program Secretariat. The address of the place of disclosure is the same located in subitem 4.2 regarding registration, item 4.0.
- 8.2 It is up to the candidate to appeal the selection process, as long as it is presented in the Program's own form and delivered to the secretariat of the Program, within 24 (twenty-four) hours after the official announcement of the result.
- 8.3 In the event of a tie, the order of classification of the candidates will be defined taking into account the Curriculum Vitae and, if the tie persists, the candidate with the highest age will be classified.

- 8.4 After enrollment, the advisor's vacancy will be filled immediately, with no classificatory list of candidates waiting for vacancies for reclassification.
- 8.5 The granting of a scholarship depends on the availability of funding agencies and the criteria established by the Program Board. Entry into the Program does not guarantee acquisition of a doctoral scholarship.
- 8.6 The selection will be made on the 6th floor of the Aurora de Afonso Costa School of Nursing at UFF, or in other rooms of this School, when necessary, as disclosed on the notice board of the Program Secretariat.
- 8.7 The candidate who does not attend any of the Selection steps described in this Notice will be eliminated from the Selection Process for the Doctoral Course in Health Care Sciences.
- 8.8 Upon enrolling in the program, the candidate undertakes to accept: the UFF rules, the Program Rules; the collegiate's decisions regarding pedagogical activities; deadlines for defenses and qualifications; publications of scientific article with the advisor and accomplishments of other academic activities inherent to the Doctoral Course.
- 8.9 8.9 Omitted cases will be dealt with by the Doctoral Selection Process Committee.


